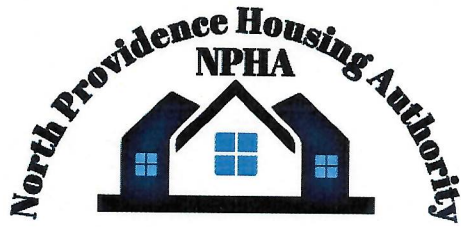

REPLACEMENT OF TEN EXISTING WOOD FENCING PATIO ENCLOSURES WITH GATES

SCOPE OF SERVICES:

The selected contractor will be responsible to provide all materials, equipment, and labor to complete the work specified below:

1. Completely take down and remove existing wood panels and galvanized poles of all ten (10) patio enclosures and gates.
2. Install and cement new galvanized poles with Grey Driftwood Vinyl pole overlay with caps.
3. Erect new Grey Driftwood Vinyl Privacy Fence Panels six (6) feet in height (see attached sample or comparable). Width will differ per unit (must measure each unit accordingly)
4. Install new Grey Driftwood Vinyl Swing Gate also 6ft in height for each of the ten (10) units (see attached sample or comparable). Width of gate will vary according to size of patio enclosure (must measure accordingly).
5. Level out any landscape that needs to be filled underneath each enclosure in order to make fencing even.
