SCOPE OF SERVICES:

The selected contractor will be responsible to provide all materials, equipment, and labor to complete the work specified below:

WENTWORTH STREET APARTMENTS

- Completely remove and properly dispose of (10) ten hot water heaters.
- Supply and completely install (10) ten new AO Smith (short boy) or comparable 40-gallon hot water heaters in each of the ten units.
- Completely remove and properly dispose of (2) two gas boilers.
- Supply and completely install (2) two Burnham or comparable gas boilers (198K BTU)
- Boilers need to be reconnected to the existing generator.

ANDOVER STREET APARTMENTS

- Completely remove and properly dispose of (1) one hot water heater.
- Supply and Install (1) one Superstor or comparable 50-gallon indirect hot water heater.
- Completely remove and properly dispose of (1) one Gas Boiler.
- Supply and Install (1) one new Weil McLain or comparable Gas Boiler (167K BTU).

• Boiler needs to be reconnected to the existing generator.

All hot water heaters and boilers should be completely operational at completion of job. Boilers must be reconnected to the existing generators on site and fully functional.
